



Terms & Conditions

IDENTIFICATION:

Reservations made **MUST** be in the **FULL NAME** as it appears on the passport. Name changes can be made to the reservation by sending an email to trips@kim-travels.com. Once final payment is made, guests will be responsible for all name change fees, if applicable.

PAYMENTS:

ALL PAYMENTS MADE TO KIMTRAVELS ARE NON-REFUNDABLE AND NON-TRANSFERABLE. Payments will start the 15th of each month after the date of the initial deposit and will be due each month thereafter until the balance is paid in full. The reservation must be paid in full no later than February 15, 2023. Failure to make monthly payment will result in cancellation of reservation. You may prepay the reservation at anytime.

REFUNDS AND CANCELLATION:

Due to contractual agreements with hotels, transportation companies and vendors we are unable to refund any monies paid on the reservation. All payments made to KimTravels are non-refundable and non-transferable. Should you need to cancel the reservation for any reason, you **MUST** notify us in writing at trips@kim-travels.com.

ITINERARY PACE:

Our escorted trips are active and may require walking over uneven surfaces or navigating steep steps or slopes. Wheelchairs, walkers, scooters and service animals are not permitted on this international escorted tour. Participants with any form of physical disability, sight or hearing impairment, which may prevent readily understanding and following instructions, are required to provide notification prior to the reservation. KimTravels has the right to reject participation or remove any individual from a tour who has not provided such notification. As such, expenses, including cancellation fees and/or costs for alternate travel plans or to return home will be borne by the passenger.

TRAVEL INSURANCE:

All traveler's are responsible for securing his/her own travel insurance. It is strongly recommended that clients purchase travel insurance to protect themselves for reasons of cancellation or illness prior to or during travel. In the event a traveler becomes ill during the trip and has not purchased insurance, all hospital and medical expenses are the

traveler's responsibility. Furthermore, should you decide not to purchase travel protection all cancellation expenses incurred will be at your (the traveler's) expense.

PHOTOGRAPHY RELEASE:

KimTravels may take photographs or video of its trips and trip participants. By signing, you give permission to KimTravels to use such videos or images for promotional or commercial use without payment or compensation to participant. Should you choose not to provide permission, you are required to provide notification 60 days prior to travel. As such, you understand you will not be in any photographs taken.

ADDITIONAL INFORMATION:

- US Citizens are required to have a passport for this trip valid six months beyond the travel dates which should not expire before November 1, 2023.
- Travel documents will be emailed three weeks prior to travel.
- We may decide to include flights at a later date if we have at least 10 guests departing from one gateway. Should you decide to purchase flights, please plan to arrive at Cartagena Rafael Nunez Airport, Colombia (CTG) on April 20, 2023. Your departure flight should be scheduled for the morning of April 25, 2023. Once you have purchased your flights, please ensure you provide the flight details within 60 days of departure.
